Declaring a Failure of Bidding and Recommending Re-Bidding for the Procurement of One (1) Year Health Maintenance Organization (HMO) Program for All Officials & Employees of the OSG

Whereas, on 28 July 2020, the Chief Accountant, Accounting Division, Financial Management Services of the Office of the Solicitor General (OSG) issued a Certification of Availability of Funds (CAF) in the amount of **Six Million Pesos (Php6,000,000.00)** to cover the **Procurement of One (1) Year Health Maintenance Organization (HMO) Program for All Officials & Employees of the OSG**;¹

Whereas, indorsed to the Bids and Awards Committee (BAC) is the approved Purchase Request (PR) No. 020-08-088 dated 06 August 2020 amounting to **Six Million Pesos (Php6,000,000.00)**;²

Whereas, the BAC conducted a Pre-Procurement Activity on 09 July 2020 to discuss certain matters and/or issues regarding the procurement, and to determine its readiness for the procurement;³

Whereas, the OSG advertised the Invitation to Bid in the Philippine Government Electronic Procurement System (PhilGEPS);⁴

Whereas, in response to the OSG's advertisement, Etica General Life Insurance and Cocolife-Philippine British attended the Pre-Bid Conference held on 20 August 2020;⁵

Whereas, on 04 September 2020, during the Submission and Opening of Bids, the BAC did not receive any bid for the Procurement of One (1) Year Health Maintenance Organization (HMO) Program for All Officials & Employees of the OSG;


