Resolution No. 06-2022

**RECOMMENDING AWARD OF THE UNSERVICEABLE ICTE
AND VARIOUS OFFICE EQUIPMENT AND DECLARATION OF
FAILURE OF PUBLIC AUCTION FOR THE SALE OF PRINTER
TONERS**

Pursuant to Section 79 of Presidential Decree No. 1445 Series of 1978, in relation to Commission on Audit (COA) Circular No. 89-296, the Disposal Committee of the Office of the Solicitor General (OSG) recommended for the disposal of the following lots:

a. Lot 1-unservicable ICTE and various office equipment with a lot price of One Hundred Sixty Three Thousand Three Hundred Thirty Three Pesos and Fifty Centavos (Php160,833.33); and

b. Lot 2-printer toner cartridges with a lot price of SEVEN HUNDRED SEVENTY SIX PESOS AND THIRTY THREE CENTAVOS (PHP776.33).

WHEREAS, on July 12, 2022, the OSG Special Bids and Awards Committee (SBAC) conducted a public auction via Zoom Video Conference;

WHEREAS, when the deadline for submission of bids lapsed on July 12, 2022 at 1:00 pm, a total of six

(6) bids were received for Lot 1, while no bid was received for Lot 2;


WHEREAS, after the eligibility check and evaluation of technical and financial documents of the bidders for Lot 1, the bid offer of JAYLOT TRADING in the amount of ONE HUNDRED SIXTY THREE THOUSAND THREE HUNDRED THIRTY THREE PESOS AND FIFTY CENTAVOS (Php163,333.50) was declared as the Highest Responsive Bid;

WHEREAS, the auction for Lot 2 was declared as a failure there being no bidder who participated.

NOW, THEREFORE, in view of the foregoing, the OSG Special Bids and Awards Committee **RESOLVED**, as it hereby **RESOLVED**, to declare **a) JAYLOT TRADING** as the highest calculated and responsive bidder- for Lot 1- unserviceable ICTE and various office equipment, and award the claim subject to their compliance to post-bidding procedures as the SBAC may herein after directed and **b) FAILURE** of bidding for Lot 2-printer toners, which can now be disposed through destruction.

This resolution shall take effect immediately.


